## PENALTIES FOR VIOLATION REGULATORY DOCUMENTATION

Appendix No.2
TO THE PARTICIPANT GUIDE

In the event of a violation of the Participant Guide by a person associated with the Event (including, but not limited to, a person participating in the Event, involved in its organization or execution (Participant, client, agent, supplier of goods, works, or services, and others), or a person present on the Event premises), penalties and/or liability measures provided for in this section shall apply.

If several violations are indicated in one clause, then penalties /liability measures should be applied for any and each of these violations. Penalties /liability measures are applied separately for each fact of violation. Several types of penalties/liability measures may be applied for a single violation.

1.	Installation on 06.10.2025 (from 20:01 at the venue of the Event) and after this date	RUB 800,000 and revocation of access to the current and the next Event
2.	Exceeding the permissible noise level (50 dB)	RUB 50,000 and disconnection of the noise source from the power supply until the end of the Event
3.	Use of open flames, welding, or hot works in places not designated for this purpose	RUB 100,000 and revocation of access to the next Event
4.	Early departure from the Event (before its official closing), non-operation of the booth (including early dismantling of the booth/workplace), or absence of the Participant's representative at the workplace for more than 30 minutes during Event working hours	RUB 200,000
5.	Unauthorized connection of equipment to the communication channels of the MKDC "Gelendzhik Arena"	RUB 20,000 per unit of equipment and disconnection of the signal source
6.	Unauthorized connection of electrical equipment to the MKDC "Gelendzhik Arena" power supply network	RUB 100,000 per unauthorized connection and revocation of access to the next Event
7.	Use of adhesive tapes that leave residue on floors or other pavilion structures	RUB 50,000 and mandatory repair/removal of damage
8.	Use of spark-generating power tools, open flames, or demonstration of exhibits/products involving open flames; launching fireworks, salutes, fire shows, or pyrotechnic effects without approval from the Fire Safety	RUB 500,000.

34.	Unauthorized connection of network equipment, use of wireless access networks (Wi-Fi) and other radio transmitting facilities on the Event premises	RUB 200,000

The basis for the imposition of a penalty is the drawing up an Act on the commission of a violation by persons authorized by the Operator or the Technical Service of the Event.

Payment of the penalty does not exempt the Participants of the Event in respect of which a penalty is imposed from fulfilling the requirements and instructions submitted by the Operator or the Technical Service of the Event.
