Appendix D
TO PARTICIPANT'S GUIDE

Version 25.08.2025

In case of violation of the requirements of the Exhibition Participant's Management to the person associated with the Exhibition (the person participating in the Exhibition, in its organization and holding (the Participant,

the Customer, the agent, the supplier of goods, works or services and others) or the person located at the Exhibition), penalties/liability measures provided for in this section shall be applied.

If several violations are specified in one paragraph, then penalties/penalties shall be applied for any and each of the specified violations. Penalties/penalties shall be applied separately for each violation. For one violation, several types of penalties/liability measures provided for such violation can be applied.

1.	Installation of 05.07.2026 (from 00:01 at the place of exhibition) and after this date	800,000 RUR and deprivation of admission to the current and next INNOPROM exhibition
2.	Exceeding permissible noise limits (50 Db)	100,000 rubles and disconnection of the noise source from the power supply until the end of the Exhibition
3.	Use of open fire in the performance of works, welding or firing works in places not assigned for this purpose	100,000 RUB and denial of admission to the next Exhibition
4.	Penalty for early departure from the exhibition (until its official closing) or for non-operation of the stand (including early dismantling of the stand)/Workplace or absence of the Participant's representative at the Workplace for more than 30 minutes during the working hours of the Exhibition	RUB 300,000
5.	Unauthorized connection of equipment to communication channels of the Exhibition Center	RUB 200,000 for each piece of equipment, disconnection of signal source and exclusion from the next Exhibition
6.	Unauthorized connection of electrical equipment to the electrical network of ICC Yekaterinburg-EXPO	100,000 rubles for each unauthorized connection and deprivation of admission to the next Exhibition
7.	Use of adhesive tapes, metal hooks with independent sticking by the Participant of stands (including double-sided tape with independent sticking by the Participant of stands of "Standard" and "Business" category), polluting surfaces of structures of stand elements (wall panels, information racks, frieze), floor or other structures of the pavilion to which fixation was carried out	200,000 RUR and repair of damages, removal from the Exhibition territory by the Organizer/Technical Service or Security Service, closure of the Participant's Workplace/Stand (Exhibitor), deprivation of admission to the next exhibition
8.	Use of furniture from other stands	200,000 rubles and removal from the Exhibition territory by the Organizer/Technical Service or Security Service, closure of the Participant's Workplace/Stand (Exhibitor), deprivation of admission to the next exhibition
9.	Use in buildings and exhibition pavilions of spark-	500,000 rubles and removal from the

11.	Absence of the Exhibitor/Co-Exponent's representative at the stand during the Exhibition	50,000 rubles, removal from the territory of the Exhibition, deprivation of admission to the next exhibition
12.	Trading without prior agreement with the Arranger	250,000 rubles and removal from the territory of the Exhibition
13.	Reduction of width of passages, obstruction of escape routes, main and spare exits, approaches to technical premises, fire gaps between walls of buildings and stands, expositions, racks, approaches to fire warning devices, cabinets of fire cranes, fire extinguishers, electric panels and other technological equipment with various goods, equipment, property, containers, packaging and other devices preventing evacuation of people	500,000 rubles and suspension of works/work of the stand/workplace - until elimination of violations. In case of repeated violation - removal from the Exhibition territory, deprivation of admission to the next exhibition
14.	Smoking (including electronic cigarettes and other heating devices) at the workplace, the territory of the exhibition hall, stand, exposition, in the administrative, production, technical or warehouse premises, in other places not installed for this purpose	RUB 300,000
15.	Building a stand of more than one floor without preliminary registration and payment of a mark-up for the number of floors or without approval of the documentation of such stand.	500,000 rubles and suspension of work until the mark-up for the floor is paid
16.	Co-Exponent's participation in the Exhibition without paying the registration fee for Co-Exponent.	100,000 rubles for each Co-Exponent and deprivation of admission to the current and next exhibitions. The penalty shall apply to the main Exhibitor/Participant.
17.	Violation of the Rules of presence at the Exhibition, other requirements of the General Conditions and the Guide of the Exhibition Participant.	Suspension from participation in the Exhibition/Prohibition of stay at the Exhibition/Removal from the Exhibition by the Organizer/Technical Service or Security Service

Violation of the requirements for exhibits, intellectual property objects, information and advertising materials established by the Regulations of the Exhibition and the legislation.	250,000 rubles and removal of exhibits, advertising and other materials and structures from the territory of the Exhibition.
20.	Reputational damage to the Exhibition or the Organizer	1,000,000 RUB and removal of the Participant from the Exhibition territory without indemnification and without return of the cost of participation
21.	Violations of fire safety requirements that caused a fire (fire) that caused damage to the property of the Yekaterinburg-EXPO ICC, the Organizer, the Exhibition Participants and other persons, life and health of people	Indemnification and deprivation of admission (indefinite)
22.	Carrying out excursions and cultural and mass events, distribution of tickets, carrying out any other commercial, advertising, entrepreneurial activities without written approval by the Organizer	RUB 300,000
23.	Inscription and pasting of announcements, posters and other information products	50,000 RUB/per unit
24.	Transfer or sale of a pass (ticket or badge) to a person to whom the pass was not issued by the Organizer, or to a person not specified on the pass. Use a pass (ticket or badge) issued to another person.	500,000 rubles/per unit and cancellation of the ticket or badge of the offending person without return of the cost
25.	Entry into fences, offices, sites and buildings covered by the Organizer/Participants for visiting	RUB 300,000
26.	Clogging of the Exhibition territory with garbage, breakage of green spaces	100,000 rubles.
27.	Visit to the territory of the Exhibition with dogs and other animals (except guide dogs)	50,000 rubles.
28.	Being in dirty clothes or non-conforming format of the Exhibition (non-white style of clothes)	50,000 rubles.

32.	Failure to comply with the verbal or written request of the Organizer to stop the violation or eliminate the violation within the specified period	Removal of the Participant from the Exhibition. Closing of the Participant's Workplace/Stand (Exhibitor). Termination of installation works.
33.	Presence on the territory of the Exhibition of persons who are not provided for by the General Conditions, the Participant's Guide or agreement with the Organizer, or in violation of the conditions of stay (persons who have not received a badge/have not purchased a ticket in accordance with the established procedure, etc.)	Removal of a person from the Exhibition territory by the Organizer/Technical Service or Security Service
34.	Violation of sanitary requirements	Non-admission to the territory of the Exhibition, removal of a person from the territory of the Exhibition by the Organizer/Technical Service or Security Service. The cost of registration fee, ticket or participation is not returned.
35.	Unauthorized connection of network equipment, use of wireless access networks (Wi-Fi) and other radio transmission facilities in the territory of the Exhibition	RUB 300,000
36.	Failure to comply with the requirements of Section 8.4 of the Participant's Guide (absence or non-compliance of exhibits, models/models, samples of	10% of the contract price taking into account the integral parts to it concluded between the Participant and the Exhibition

39.	Height of the non-equipped Workplace is less than 3 (three) meters	RUB 300,000
40.	Construction/overlapping of an unequipped "island" and "peninsula" Workplace with blind walls for more than 50% on the side of passageways	RUB 300,000

The basis for imposing a fine is the preparation by persons authorized by the Organizer or the Technical Service of the Exhibition of an Act of Violation.

Payment of the fine shall not exempt the Participants of the Exhibition against whom the fine has been imposed from compliance with the requirements and instructions presented by the Organizer or the Technical Service of the Exhibition.

ADDITIONAL CHARGES FOR LATE ORDERS AND PAYMENTS FOR SERVICES THAT ENSURE PARTICIPATION IN THE EXHIBITION

Agreements to secure participation less than 10 days before the date of the Exhibition, as a rule, are not concluded.

Integrated Service Category	Provision of participation in the equipped exhibition area
Conditions for application of mark-ups	It is used by the Organizer to calculate the cost of services to ensure participation in the Exhibition at the conclusion of the Agreement for participation in the equipped exhibition area of any category within the period of validity of the mark-up.
Mark-up amount and validity period	Mark-up 1:15% of the cost of services excluding the cost of additional services and registration fee for payment in the period from the 20th to the 13th day before the date of the Exhibition. Mark-up 2:30% of the cost of services excluding the cost of additional services and registration fee if paid less than 13 days before the date of the Exhibition. Mark-up 3: for the improved location of the stand: the location of the stand in the first line from the entrance to the MTC "Yekaterinburg-Expo." The mark-up when paying for services shall be applied if it is provided for at the conclusion of the Agreement or in case of payment for services during the period of validity of the mark-up in violation of the terms provided for by the Agreement.

MARKUPS FOR LATE PAYMENTS FOR ADDITIONAL SERVICES

1. The mark-up shall be applied by the Organizer to calculate the cost of Additional Services on the equipped exhibition area of any category. Unpaid applications formed in the Personal Account prior to the start of the mark-up validity period are cancelled and must be re-formed with recalculation of the value according to the amount of the mark-up.
2. Applications for additional services less than 9 days before the date of the Exhibition are usually not accepted. If the amount of Additional Services payment is received less than 9 days before the date of the Exhibition commencement, the Organizer shall have the right not to provide services.
